Family and marital status are protected in all the areas protected under the Act, which are: statements, publications, notices, signs, symbols, emblems or other representations that are published, issued or displayed before the public goods, services, accommodation or facilities customarily available to the public

Family statusis defined in the Actas the status of being related to another person by blood, marriage or adoption. The Actprohibits discrimination or negative treatment towards an individual based on their relationship to a family member.

The Code includes two grounds that provide protections for persons in relationships: marital status and family status. " Marital status " is defined in section 10 of the Code as " the status of being married, single, widowed, divorced or separated and includes the status of living with a person in a conjugal relationship outside marriage " , including both same-sex and opposite sex relationships.

Analysis of cause-specific mortality was also stratified on family status, but due to small samples, restricted to single, married and children status up to 75 of age (Table 6, Table 7).
